_____ **Pay Tuition and extra-curricular activities using check/cash only:** Tuition is due by the first of every month. If payments are not paid by the 10th of each month, a late fee will be charged to your account.

_____ **Pay tuition using credit/debit card or auto draft payment:** Tuition will be paid using one of these methods and we agree to pay the \$150 processing fee per child, due at time of registration.

_____ **ESA:** Families receiving the ESA grant must provide the school with the award letter from the ESA stating the amount of funds to be received. A processing fee of \$150 per child will be charged, due at time of registration.

Late Fees: Tuition is due on the 1st of each month. A late fee of \$25 per month will be added to your account if your payment is received after the 10th of each month.
